It applies to Nasophyengeal radium treatments and the cancer it caused. The Atomic Veterans Medal Act HR-432 is still on the back burner. Next is S-1385 by Senator Paul Wellstone for three cancers. This was voted on last year and listen to this story, it was voted on and was a tie and then an anonymous senator cast a "no" vote and we lost by one vote but we cannot find who cast the dissenting vote and they tell us that it's legal. I personally beg to differ with them. Next is HR-2401 by Congressman William Lipinski of IL in regards to genetically affected children of atomic veterans. This is also on hold. Next is Congressman Lane Evans bill HR-4368 returning the cancers that were deleted from Senator Wellstone's Bill S-1385. I also would like to thank personally all the Atomic Veterans that wrote in to their local legislators and requested their support for S-1385. This is why the vote was so close because the rank and file got involved with the due process and also I would like to thank all the State Commanders that wrote for their support. You did a fine job and keep up the good work and a special thanks to Florida State Commander Dorothy Stanco for the great job she consistently does for our organization and another special thanks to State Commander Robert C. Carter of Utah for the large donation that he acquired for us. I have been talking to our new newsletter editor about featuring a new State Commander in each issue with a picture and an article about him or her and what they are doing in their respective states and a little about themselves so we all can get to (cont'd on Page 3)

Our crusade for Compensation, a Medal, and other, keep going from the front to the back burners in Washington. Granted, we have some dedicated representation by a certain few (refer to the Commander's Corner), but they are fighting the system along with us. Let me emphasize that I am not against filing for Compensation or the Medal. I fully back the efforts to obtain both. However, we do have certain benefits that can help alleviate pain and suffering while we are still living, those being the legislation's already in place that allow medical treatment for many of our physical problems. However, even this is being attacked by the "Administration Proposed year 2000 Budget" with it's shortfall of some \$3.5 billion for the VA Medical Facilities (see more on this on other pages). Persons from the VA Medical Facility are not coming looking for you. You must go to them, get on the Ionization Radiation Exposure Register (if not already on it), take the physical and get on with treatment you are

Entitled to. Too often in discussions with Atomic Veterans around the country when I ask if they are taking advantage of medical treatment I am informed that they are only interested in Compensation and or a Medal. Compensation comes slowly as we all know well and will come slower yet if the Administration's Proposed Year 2000 Budget is passed with it's \$3.5 billion cut of VA Medical Facility funding. There is more on this on following pages. We need to contact our Representatives and Senators and let them know our feelings on this. My personal opinion is that unless they can come up with the funds first to take of medical and other problems the troops receive when sent into all of the different "brush fires" currently taking place, and in the future, then the troops should not be committed in those areas. Take care of past obligations first and as well. My understanding of Bills that were presented in the 105th Congress will probably be reintroduced and under new Bill numbers.

In previous newsletters there have been articles in multiple parts whereby all of the parts have not been published. As these articles are beneficial to the membership I would like to ask the authors of same to submit the missing parts to me in order that they may be published. Thanks!

I am asking the Treasurer of NAAV at this time to submit a Report for publication in the next issue in order that the membership can be informed of our financial condition. U.S. Sees No Thyroid Harm from Hanford Nuclear Plant:

Atlanta (Reuters) - There is no evidence that radioactive byproducts from nuclear weapons production in the 1940s and '50s increase thyroid disease among residents of Washington State, federal health officials said last month. [Editor: Another bureaucratic study, cost unknown, clearly supporting the 'party line", as we Atomic Veterans know too well. Funding for these studies, because the result is pre-established beforehand, is a 'waste' as are the 'dose estimates' which we are familiar with from Mr. D.M. Schaeffer with the Defense Threat Reduction Agency, formerly the Defense Nuclear Agency or DNA, another name change necessitating in additional wasted funds for letterheads, telephone directory changes, etc. We should partition our Representatives & Senators to disband this agency and divert that funding to VA for compensation and medical treatment where the funding will do the most good and not be hampered by any further erroneous data from them].

"The Way I See It!"

Have you ever said to yourself; Self, what can I do that will help, not just myself, but my fellow Atomic Veterans? I think most of us know other Atomic Veterans that are hurting, with medical and/or financial problems, because they honorably served their country. Some of us [Dick Conant and myself to name two], feel that we should do all that we can do to make our fellow Atomic Veterans aware of programs that are already in place to help those who need medical care. We haven't stopped trying to get our elected representatives to correct the laws that now exist, and make all radiogenic illnesses presumptive. We have even tried for years to get a radiation medal for those who deserve it and want it. We know that exposure to nuclear radiation caused our cancers, and other conditions, and our government denies responsibility. The fight has gone on for so many years to get just a few cancers/conditions made presumptive for when we must file claims. It seems that everyone, except our own government, knows that the required dose estimates are just a dirty joke and that all radiogenic conditions should be made presumptive. But how do we convince our members of congress to do it? Too few members of congress are veterans and too few remember what times were like when there was a real danger that communism would take over the whole free world and our country along with it. How many of them remember how the Cold War and nuclear arms race started? Do they remember the late 1940s and early 1950s when Communism took over all of eastern Europe and much of Asia; when the USSR had 200 heavy bombers and China had 5 to 15 Armies just over the border f Manchuria from Korea - just daring us to set one foot over the border to start WW III? Do they remember the spies and traitors like Fuches, Gold, Greenglass and the Rosenbergs who sent all our nuclear secrets to the Russians? How this caused our civil and military leaders to think that the USSR might be ahead of us in the nuclear arms race? How many think that Joe Stalin would not have used the H-bomb on us if he had developed it first and had the means to deliver it? These points and many others caused the rationale of the times. Our military leaders, and right on down to NCOs and below, were so driven by the urgency of the times and fear for the safety of our country that they could justify [at least in their minds], the, at times, near total disregard of test participants safety and then falsifying the records to cover their own rears. You cut corners and so did I, we had to get our jobs done now. If a few rules had to be bent, they got bent. This was the mentality of the times and if our present members of Congress didn't experience it, they wouldn't understand it, or even believe it. The "Official Records" don't show it. How many of us have been shocked and horrified reading the lies and cover-up in the "Official Records" of our tests?

Have you ever tried to get the records corrected? I have. It can't be done. With a few exceptions like Senators Wellstone, Murry, Rockefeller, Rep. Evans and a few others, those in congress believe the "Official Records" or just don't care. We have to keep trying but I don't believe we will ever see full justice, while any of us still live. We had better use what is already on the books, Medical Care. Remember how in the 1980s and early 1990s it was almost impossible to get information on VA programs and health care: when you could get some Medical Care for radiation caused cancers and conditions but would get kicked out on a regular basis because "your condition was not service connected"? Some of us tried to get help from the big veterans organizations National Service Officers to file for priority medical treatment under PL 97-72. But most knew nothing about PL 97-72 and would say "file a claim" and not help with what you asked for. We had to do it on our own. That was back when there was something like 1700 claims filed and less than 25 granted. There was really no place to get our questions answered.

In the Spring of 1995 some atomic veterans met with the Albuquerque VA Medical Center Assistant Director and Volunteer Services Department Chief to complain about the problems encountered by atomic vets trying to get medical treatment at the facility. They complained that there was no way to find out what the VA policy on treating radiation exposed veterans was and that the doctors and medical staff didn't know and even the hospital staff didn't understand the eligibility rules. I understand the meeting was lengthy and Assistant [now Associate] Director Spencer Ralston was impressed. Mr. Ralston took it on himself to see that this segment of the veteran population would no longer be neglected and started working on a system to alleviate the problem. He and others worked out a plan that would include atomic veterans in an existing program, the Veterans Advocacy Council and start a new program, the Radiation Exposed Veterans Advisory Committee, to address problems of radiation exposed veterans. I was invited to become a member of these groups, was honored to accept and attended my first meeting in May 1995. These groups were composed of the VAMC Director, Associate or Assistant Director, Department Heads, representatives from VA Regional Office, veterans organization NSOs, NM State Veteran Service Commission Director and me. In these groups you meet the top people, people that can [and do] take care of the problems that we bring up for our veterans group. We have been treated very well. Every problem that Dick or I have brought up [mostly complaints from NM Atomic Vets] has been taken care of to our satisfaction. As you might imagine, there were some clashes in the beginning for the advisory committee but I think things worked out well for all concerned. Things got much better for me when Dick Conant became (cont'd Page 6)

Active in NM NAAV in 1996. We have been given "Fact Sheets" on VA rules and how they applied, updates on everything that changes and instruction on how things work at the VAMC. When the VISN Networks came into being, we were invited to become members of the Management Advisory Council. Several of our suggestions have been incorporated in the VISN#18 plans and aims. Any information that we get that we feel would be useful to Atomic Vets, we send to the National Commander and put it in our New Mexico Atomic Vet Newsletter. You might find it useful to check at your own VA Medical Center to see if there are any such programs in place that would be of help to Atomic Vets in your area. It does take a lot of time and effort but we feel that it is worth it. You will find, as we did, that the VA Medical Centers employ a lot of very good people.

From a Recent "Stars & Stripes:

Independent' Groups Charge Clinton VA Health Budget \$3 Billion Less Than Needed.

Four major veterans groups tore into President Clinton's proposed \$44 billion fiscal year 2000 budget last week, asserting as nearly than \$3 billion less than adequate for veterans health care, which amounts to \$17.3 billion of the total. In submitting their 13th annual independent budget, AMVETS, Disabled American Veterans, Paralyzed Veterans of America and the Veterans of Foreign Wars said the shortfall was "so significant" that it imperils the health and benefits of millions of American veterans." ******* The organizations said the president's budget would eliminate "almost 8,000 full-time employees from VA health care." ******* "The claims backlogs still range in the hundreds of thousands," the veterans groups said. ******* And said that "the VA's inability to significantly improve the quality and timeliness of benefits claims has been and continues to be one of the most serious and persistent problems." [Ed: It appears to me to be exceptionally easy for the "establishment" to find funds for all types of causes - except Veteran Causes].

Stump, Stearns, Wellstone Slam White House VA Health Care Budget Proposals:

President Clinton's budget shortchanges veterans and is based on faulty assumptions, House Veterans Affairs Committee Chairman Bob Stump, of Arizona, charged Feb. 1. ********* "The administration's proposed spending level for VA health care is a slap in the face of every veteran," Stump said. "It ignores the increasing cost of caring for veterans, especially the aging veterans of World War II who depend on VA health care."

Editors note: It appears to be easier and easier for the Washington bureaucrats to send Troops into "harms way" (some 44 brush fires I recently observed on a CNN report) with total disregard and apparently no consideration of funding to take care of their wounds, illnesses, and other. Fortunately we still have a few dedicated persons in the House of Representatives and Senate who are on the side of veterans. It is much easier to send troops into harms way than go one's self, apparently - as many of our current officials in Washington are not veterans. They are either ignoring, or don't care, about the fact - that if it were not for the past efforts and sacrifices of veterans and their families -the lucrative positions which they now hold might well be that position of making small rocks from large one's for some foreign power!

It is imperative that veterans contact the Administration, their Representatives and Senators by any means and outline their views on the pending budget and other legislative subjects regarding veterans. Also, please contact the offices of Stump, Stearns, Wellstone and Evans and thank them for their support.

"LATE SCOOP!"

In answer to a faxed inquiry by Dale Howard to Senator Wellstone asking if the Senator had reintroduced or was going to reintroduce the "Justice for Atomic Veterans Act", Senator Wellsone's Office sent 16 pages of the Congressional Record on 3/8/99. Excerpts follow:

Senator Wellstone introduced it as Amendment #27 to S-4, Senator Warner's [and 30 cosponsors] "Soldiers', Sailors', Airmen's and Marines Bill of Rights Act of 1999". He introduced it with the 10 cancers/conditions that was contained in S-1385. The Amendment was replaced with a modified version tat contained only Lung and Colon cancer and Tumors of the brain and central nervous system. The modified version of Amendment #27 was added to S-4, which passed by a vote of 91 to 8.

Senator Wellstone made a brilliant speech with his introduction in which he pointed out [1] the proof and support given at the April 1998 hearing on S-1385 [2] the letters of support by DAV and American Legion [3] the support of the Independent Budget for fiscal year 2000 by AMVETS, DAV, PVA and VFW that includes funding for this bill and [4] the support by VA Undersecretary Kenneth Kizer.

{Editors Note. If you use the Internet, check out the Congressional Record on "Thomas" and see if you agree and think it is obvious that Senator Wellstone tried to sneak the complete version of S-1385, 10 cancers/conditions, through to passage].






