The following are acceptable forms of personal identification:

- REAL ID compliant State-issued driver's license or identification card issued by the Department of Motor Vehicles (or equivalent) or one of the following:
- U.S. passport
- U.S. passport card
- U.S. Customs and Border Protection trusted traveler card (Global Entry, NEXUS, SENTRI, FAST)
- U.S. military ID card
- U.S. military dependent's ID card
- Department of Homeland Security-designated Enhanced Driver's License
- Native American tribal photo ID
- HSPD-12 PIV card from any government agency (for identification only)
- Transportation Worker Identification Credential (TWIC)

An individual needs to present one of the following documents with their non-REAL ID compliant state issued driver's license or identification card.

- Federal, state or local government issued credentials for first responders with photograph
- Birth Certificate (original or certified copy)
- U.S. Coast Guard Merchant Mariner Card
- Certificate of U.S. Citizenship (Form N-560 or N-561)
- Certificate of Naturalization (Form N-550 or N-570)
- U.S. Citizen ID Card (Form I-197)
- Native American Tribal document

An individual with only their non-REAL ID compliant state-issued driver's license or identification card. Must be escorted at all times. See Escort Ratio Chart listed below:

Exceptions: Visits dealing with Security Plans and Public Tours are not included
