Right or wrong, I believed the members would want me to concentrate on benefits/legislation, especially since at the end of December 2022, we would have to start all over with new legislation. As you'll read in this newsletter we have

accomplished a lot.

RECA (Radiation Exposure Compensation Act) was set to expire July 11, 2022. It now extends to June 7, 2024.

Enewetak Atoll Radiological Clean up Veterans were not recognized as Atomic Veterans.

Polomare Spain Broken Arrow Clean up Veterans were not recognized as Atomic Veterans.

Thule Greenland Broken Arrow Clean up Veterans were not recognized as Atomic Veterans.

Passage of the PACT Act now recognizes each of these groups as Atomic Veterans.

We didn't have an Atomic Veteran's Service Medal. DTRA has them in the works.

We didn't have a memorial Bridge in New York. Former New York State Commander Ed Gettler initiated this effort and saw it dedicated in July.

We didn't have a memorial Highway in Missouri. Missouri State Commander Bernie Crosby made that happen.

We didn't have Ohio recognizing Atomic Veterans Day. Past State Commander David England and Ohio State Commander David Crawford brought that about.

We didn't have National Atomic Veterans Day perpetually. Gillie Jenkins and his Representative Abigail Davis Spanberger (VA-7) (their story in next newsletter)

were instrumental in getting this proclamation signed by President Biden.

We didn't have a Multigenerational Legacies of Trauma. This has the potential to provide information for getting benefits for our children. Dr. Yael Danieli and Kathy Sinai were the key driving force behind this (with support from LabRats and others.)

All of the above we didn't have a year ago, we now have all of these.

I'm sure I've missed some accomplishments.

We aren't done yet.

I hope all of you were able to honor July 16th, 2022, Atomic Veterans Day appropriately.

We have been invited to both the British All Test Reunion and the BNTVA Convention, for a number of reasons, we have had to send our regrets for this year.

Passage of the PACT Act!

The <u>#lookmeintheeye</u> campaign made history on the 8th June 2022 when the UK Prime Minister, Boris Johnson became the first Prime Minister to officially meet with nuclear test veteran representatives and listen to their stories.



The meeting was organised by Rebecca Long-Baily MP who had invited Sir John Hayes MP to the meeting as he has long been a campaigner for the nuclear veterans and supports medallic recognition for the veterans, including asking the Prime Minister to take personal responsibility for the matter.

Representatives of the Office for Veterans Affairs and the Minister for Defence People and Veterans Leo Docherty listened to the testimonies and the evidence.

Listening to the stories of John Morris, Laura Morris, Steve Purse, Jacqueline Purse, Laura Jackson, and Alan Owen the PM was shocked to hear the trauma of the tests and how it has affected the servicemen and their families.

The meeting was scheduled for 30 minutes, many rehearsals had taken place, lots of hours preparing for the meeting by the working group, many meetings beforehand, and a lot of organisation to get to this stage.

The PM gave us 40 minutes of his time, which we are extremely grateful for, he has stood by his promise to meet with us and look us in the eye. John Morris who was present at Operation Grapple said to the PM "You have looked me in the eye, you can now tell me that I am worthy of recognition or tell me to sod off."

We continue the pressure with the campaign with support from all political parties, we have given the PM a deadline of the 3rd of October 2022, the 70th anniversary of Operation Hurricane, the first British Detonation. We requested a ceremony to mark this anniversary, at which the 70 years of denial can end.


It is now in the hands of the Prime Minister, he alone can make this happen, he has already sat and listened, kept his promise, now he needs to act and end 70 years of injustice.

We are not finished; the campaign was to get the Prime Minister to look us in the eye and he has kept to his word. We will wait and see if he becomes the first Prime Minister to end 70 years of injustice.

PRESIDENT BIDEN SIGNS VETERAN BILLS

NAAV Director/past National Vice Commander Lincoln Grahlfs and the National Commander, Keith Kiefer, had the honor of witnessing the signing of nine bills intended to benefit Veterans.

Among the bills was a two year extension of the Radiation Exposure Compensation Act (RECA). Prior to this bill becoming law, the program was slated to sunset on July 11, 2022.

If nothing more is done, this extension will sunset on June 7th, 2024. NAAV continues to advocate for extension and expansion of the program.

Lincoln will become 100 years old in December. President Biden said he will send him a birthday card. Lincoln and the President talked for about twenty five minutes. Ten of those twenty five minutes can be seen on a CSPAN video just after the twenty minute mark. We managed to pull the PACT Act (although renamed) across the finish line. This is a major victory for many Veterans suffering from service connected toxic exposure. It is intended to cover three groups exposed to ionization radiation, plus victims of burn pits, victims of contaminated water, among others.

Letter of Encouragement From A NAAV Member

Greetings to all Fellow NAAV Members

I am Michael Cobb, a brother nuclear veteran, having served in VP 872 during Operation Dominic on Christmas Island. About one and a half years ago, I was diagnosed with bladder cancer. Being one of the designated cancers covered under Defense Advanced Research Projects Agency (DARPA), I filed a claim by mistake with my County Veteran Service Officer, who filed for disability with the benefits section of the Department of Veterans Affairs (VA). I should have filed directly with the Department of Justice (DOJ). Some six months into the claim I realized my mistake.

This freaked me out, and in panic, I contacted Keith Kiefer and Fred Schafer and subsequently filed with DOJ. I was under the impression that only the DOJ would pay the \$75,000, and that my claim though the VA would amount to \$3200 per month for a total of \$75,000 maximum benefit, as long as I was considered totally disabled. This was a terrible thing to contemplate as it meant to get the \$75,000, I would have to hope that the cancer remained! And I thought that the reverse was that if I didn't have cancer, I would not get the DOJ amount of \$75,000. I was told that if the required physical exam showed I did not have cancer, I would be eligible for about \$1400 a month. Accepting the VA claim seemed like a gamble to me since the DOJ claim would pay the full \$75,000 immediately. I filed with DOJ immediately.

Meanwhile the VA contacted me and advised me all the paperwork was completed, and that they had arranged for the mandatory physical exam to complete my VA claim. I requested a three-month delay since I believed this was a complication which could affect the DOJ claim, even though I had refused the physical exam thinking this would stop the process. It did not.

The VA paid on my claim retroactive to my filing date, and I received some \$42,000 total before my DOJ claim was authorized. DOJ subsequently approved my claim and paid the difference after some delay.

Having received the \$75,000 through the two claims, I was relieved and thought that was the end of it.

Now the Good Part...

The VA advised I would continue to receive the \$3200 per month until January 2022, at which time a physical exam would be required to evaluate my current status.

I was contacted by the outside contractor, which does the exams and was advised that an exam "might" be required after a review of my medical records at the VA. (The VA has been my sole provider for the past 20+ years, and my care has been fantastic. I cannot say enough good things about my Fresno Veterans Hospital.)

Subsequently I was advised no exam would be required; my records were sufficient to determine I was still classified as 100% disabled due to the cancer diagnosis.

Earlier this year, I received a cost-of-living adjustment and now receive \$3300 per month.

At this time I am undergoing a two-year treatment plan since the physicians at the Palo Alto VA felt my cancer would reoccur without further treatment.

At this time I suspect the confirmed diagnosis of cancer is considered to be a 100% disability though it may be dependent on continued treatment.

I wrote this article and shared my story to advise all shipmates and NAAV veterans who have the listed cancers to look into the Department of Veterans Affairs program through either your veteran representative at your VA, or through your State Department of Veterans Affairs, or through your County Veteran Service Office like I did. This is a veterans program in addition to DARPA, and all atomic veterans should be eligible.

I hope to see you all in August; we have a lot to celebrate with the approval of the medal!



President Biden rejuvenates National Atomic Veterans Day, lauds soldiers and the "true extent of their service"

Last month, President Joe Biden announced that every July 16 will be known as National Atomic Veterans Day. In commemoration of the soldiers who took part in nuclear testing, the battles of Nagasaki and Hiroshima, and war prisoners during these conflicts, the government engraved their effort into posterity by honoring

them on that date every year, moving forward. A warhead nicknamed "Trinity" marked the first nuclear testing done by the U.S government on June 1945, and in the subsequent years, the government would exponentially increase the amount of nuclear bomb usage for testing and warfare purposes. During its highpoint, the United States government conducted more than 200 atmospheric tests on home soil in the Southwest and in the Pacific. During the years 1946 through 1963, it is estimated that at least 200,000 American servicemen were directly or indirectly affected by radioactivity.

Aerial bomb testing, Nuclear fallout, and prolonged exposure to toxic residues on POWs are among the listed causes that affected soldiers during this period.

However, in favor of supporting American veterans, in 1966 the U.S Congress repealed the Nuclear Radiation and Secrecy Agreements Act, effectively permitting compensations and benefits for Atomic Veterans as

gratitude for their service.

At the time, Repealing the act represented a massive turning point for atomic veterans, it meant the "Veterans exposed to radiation through their service-related activities were finally able to break their silence and qualify for select VA benefits and services," Biden said during the Washington, D.C. ceremony. "Tragically, many Atomic Veterans passed away without ever receiving the health care they deserved and without their families knowing the true extent of their service."

Biden described the proclamation as "one sacred obligation" the government failed to fulfill to their veterans, highlighting the renewed commitment the U.S has to the Atomic Veterans.

"It is a mistake our country must never repeat," Biden said. "I am committed to ensuring that all of our nation's veterans and their families, caregivers and survivors have timely access to the services, medical care and benefits that they deserve.

Biden's proclamation wouldn't be the first time a U.S president commemorates the Atomic Veteran's effort. In 1983, former President Ronald Reagan decided to make homage to them proclaiming their patriotic effort as "Americans who through their participation in these tests helped lead the United States to the forefront of

technology in defense of our great nation."
"In honoring these veterans, let us rededicate ourselves once more to our national goal of a world at peace in which nuclear war is unthinkable," Reagan said at the time.
However, the proclamation made by Reagan lasted just one day. It would be 32 years until, in 2015, the Virginia House of Delegates made it so that the commemoration should occur every year, but only in that state.

Seven years later, Biden took it a step further, honoring and officializing their legacy with their own day each

summer.
"We renew our commitment to supporting Atomic Veterans and to preserving their stories," Biden said during "We renew our commitment to supporting Atomic Veterans and to preserving their crucial role in our history and our the commemoration, "so that Americans will always remember both their crucial role in our history and our aspiration for a world without nuclear weapons.'

Honoring Our PACT Act Dies and Resurrects

Strange Doings — Reappears as S. 3373 Under a New Name

Strange doings occurred in the House. The "Honoring Our PACT Act" (H.R. 3967) has undergone a metamorphosis behind the scenes since the Senate returned it to the House in mid-June. The bill reappeared in modified form as Senate Bill 3373.

S. 3373 had been originally conceived as the "Protecting Our Gold Star Families Education Act." Yet, the House gutted it, removing its text and inserting the entire text of the Senate-passed version of H.R. 3967, except for one specific clause. That clause involved the tax treatment of income derived from contract buyouts of health care professionals as authorized by Sec. 902 of the bill. Also, it renamed the act, the "Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics (PACT) Act of 2022."

The severely amended bill was then passed with a 342-88 vote by the House (H.R. 3967 passed 256-174) — suggesting, perhaps, true bipartisanship occurred — on July 13 and was on its way to Senate the following day. The President has said before he would sign the measure. It should be noted this action will cost in the neighborhood of \$433 billion for compensation and healthcare and affect about 3.7 million veterans and their survivors (100,000), according to the Congressional Budget Office. It is a significant piece of legislation, whatever its bill number and name.


Now, let us see what is in the heart of the Senate.

The bill/law Public Law No. 117-168 was signed into law August 10, 2022.

John Baenen's wish for Christmas of 2016 finally arrives in 2022.

On March 3, 2022, in a bipartisan vote, the House passed H.R. 3967, the Honoring our PACT Act. The law will impact all generations of veterans. Over 60 veteran and military service organizations supported the Honoring Our PACT Act.

DAV testified before the Senate Veterans' Affairs Committee on March 29, in support of this legislation that would:

Provide health care based on toxic exposures;

Add 23 burn pit and toxic exposure-related diseases;

Add hypertension as a presumptive disease associated with Agent Orange exposure;

Concede exposure to burn pits and toxic environments;

Provide a new framework for establishing presumptive diseases in the future;

Expand radiation-risk activities to include veterans who participated in radiation cleanup at Enewetak Atoll, Palomares, Spain and Thule, Greenland;

Include Thailand, Cambodia, Laos, Guam, American Samoa and Johnston Atoll as conceded locations for Agent Orange exposure; and

Require registries for veterans who served at Ft. McClellan and for those exposed to PFAS chemicals.

Veterans who participated in nuclear cleanups at Enewetak Atoll, in the Marshall Islands; Palomares, Spain; and Thule, Greenland would be classified as Atomic Veterans, making them eligible for benefits covering 22 diseases associated with exposure to radiation.

The Enewetak Atoll cleanup veterans were subjected to toxic levels of radiation while remediating the atoll following above-ground U.S. nuclear weapons testing that occurred from 1946 to 1958. The U.S. conducted 43 nuclear tests on the Enewetak Atoll. Four-thousand veterans participated in the radiological cleanup; only about ten percent are estimated to be alive today.

The Palomares, Spain, veterans were tasked with cleaning up the aftermath of a 1966 accident in which a nuclear-armed B-52 bomber collided with a refueling jet, releasing four hydrogen bombs over Palomares, a village in Spain. Approximately sixteen hundred U.S. Air Force members participated in the cleanup of radioactive material with <u>little-protection</u>. A similar crash in Thule, Greenland, exposed another approximately 500 cleanup veterans in 1968.

Atomic cleanup veterans have developed cancer and other chronic illnesses linked to toxic exposure. Prior to passage, only service members who participated in active nuclear tests or were stationed- or prisoners of war- in Japan after the bombings of Hiroshima and Nagasaki are authorized to receive specific benefits and services from the VA. Those who participated in the cleanup of nuclear tests or accidents prior to passage were excluded. This law rights that wrong.

A section of Highway 171 near Carl Junction between East Z Highway and Highway 43, approximately four miles long, is now designated as the "Atomic Veteran Memorial Highway."

A casual conversation between Bernie Crosby and Teresa McNaught in a doctor's office was the key to Bernie's twenty year quest to obtain a Missouri Atomic Veteran Highway. Bernie's networking with Teresa led to Teresa putting him in touch with Missouri Rep. Ann Kelly. Rep. Kelly took the ball and ran with it, linking Bernie to his State Rep. Bob Bromley. Rep. Bromley and others joined Bernie and Rep. Kelly in passing the legislation.

We all need to have the tenacity Bernie has demonstrated in the states that don't presently have an Atomic Veteran Memorial Highway.


