Farewell to NAAV National Director at Large

Dr. Lincoln Grahlfs

December 4, 1922 to October 8, 2024



It was the spring of 1947 (after Operation Crossroads) when Lincoln Grahlfs reported to Oak Knoll Naval Hospital in California. He was suffering from a strange abscess on his face, a 103-degree fever and an abnormal white blood cell count. The symptoms demanded an unorthodox treatment: A doctor shot his face with X-rays with only a shield to cover his eyes. Soon after, the abscess cleared. During his treatment the Dr. said "That was the hair of the dog that bit you." Lincoln believed he heard a coded message in the doctor's words: He knew service members were getting sick from a massive, secret U.S. government program.

Lincoln, was a retired sociology professor and a published author of the book "Voices From Ground Zero: Recollections and Feelings of Nuclear Test Veterans." He has also published a book titled "Undaunted: The Story of a United States Navy Tug and Her Crew in World War II."

Dr. Francis Lincoln Grahlfs, author, Sociologist, and long time NAAV board member, passed away on October 8, 2024. We dedicate this issue of the National Association of Atomic Veterans to his memory.

In his 20s, the petty officer first class participated in Operation Crossroads in the Pacific Ocean. Below is a photograph taken shortly after test ABLE at OPERATION CROSSROADS. Lincoln was at the helm of the rescue tug, USS ATR-40, which was in what was designated as the Salvage Unit. The USS NEW YORK was determined to be highly contaminated with radioactive fallout. They were sent to wash her down with their fire hoses (that was supposed to decontaminate her). The idiots giving the orders didn't take into consideration that the water being used for this task was being pumped from Bikini Lagoon, which was, itself, highly contaminated. As a consequence, not only did it not clean up the NEW YORK; it thoroughly contaminated the tug's water system! (This picture was obtained from the NY Times.)







Undaunted is about the summer of 1944 when the Navy assembles and trains a crew in Miami, FL and sends them to Texas where they man an ocean tug which then proceeds to the war zone in the western Pacific to perform the hazardous and unglamorous tasks of towing, rescue, and salvage necessary to support the actions of the fighting ships.

Lincoln has been a member advocate for NAAV. NARS and Veterans for Peace. We are grateful to Lincoln for his insight and guidance through the years. NAAV would not be the organization it is, if not for his dedication.

One of Lincoln's favorite quotes is "In war, everyone loses."







United We Stand

In March of this year (2020) I had the extreme pleasure of receiving a recognition award at a meeting which included both the Atomic Cleanup Veterans and the Marshall Islanders. This award means a lot to me because it recognizes a principle which I have long felt is important; that principle is enshrined in the frequently quoted line, "United we stand, divided we fall." Let me tell you why this is important for me.

I am a survivor of Operation Crossroads. I suffered health problems as a result of that experience. I also had a daughter who died of illness that I firmly believe was related to my radiation exposure. And I have a son who suffers from Addison's disease, which is a problem related to the endocrine system. The government's assertion that radiation induced ailments can't be genetically transmitted is contrary to the opinion of all the geneticists. And, for over three decades, almost every physician I consulted would rather obviously avoid the subject.

Then, in 1980, I read an article about the National Association of Atomic Veterans in my local newspaper. The organization (referred to as NAAV) had been established by another atomic bomb test survivor, Orville Kelly and his wife, Wanda, in 1979. Orville had died a few months later, but the organization survived with Wanda at the helm. I sent an inquiry immediately to the cited address in Burlington, Iowa. Quickly I was invited by Wanda Kelly to join NAAV, and before long I and two other navy veterans were appearing around Wisconsin, spreading the word.

The membership of NAAV was, of course, primarily veterans. However, not long after this, another organization, the National Association of Radiation Survivors was founded by Dorothy Lagaretta, a laboratory worker connected with the Manhattan Project at the University of California. NARS was an organization of people who had been exposed to radiation related to the Atomic Bomb. This included nuclear industry workers, radium miners, and people who lived downwind of nuclear tests: this very soon came to include Marshall Islanders. By 1984 NAAV membership was approaching a thousand; at what was its fifth annual meeting, which was held in Kissimmee, Florida that fall, Wanda announced that she was officially stepping down as Executive Director; she said she needed

more time to organize the other aspects of her life, but would still continue as a permanent member of the Board of Directors.

After almost four decades, a few of the details escape me, but my memory tells me that the person who took over leadership of the organization at that time was a fairly high ranking reserve, or National Guard officer; the headquarters also moved to Eldon, Missouri. It is also my recollection that this person brought with him a number of new members. I do know that, at the general meeting, I made a motion to the effect that we, of all people, should take a stand supporting universal nuclear disarmament and was shouted down. In response to this, several of us pretty much withdrew from participation in NAAV activities and joined NARS; NARS, in turn, took a much greater interest in veterans concerns.

Sometime in the 1990's, I ran into one of the members who had stayed active in NAAV. He told me that Oscar Rosen was now the commander, and that he had pretty much improved the situation. He told me that he really felt I should come back and help get back where they should be. I accepted his suggestion; now I would be active in both organizations.

Several years later, I had become president of NARS, and Richard Conant had succeeded Oscar at the head of NAAV. Coincidentally, on one particular occasion, both organizations had planned their annual meetings for overlapping dates at neighboring hotels in Las Vegas. Dick and I got together during that week-end and agreed that there was a lot of sense in merging our organizations; there is strength in numbers. Unfortunately, we couldn't convince the bulk of our members; while NARS, unfortunately, did not survive by itself NAAV ultimately did.

Today, more than ever, the mere existence of nuclear weapons endangers life as we know it. For that very reason, I was pleased to participate in a meeting which brought together Atomic Veterans, Cleanup Veterans and Marshallese people for a common cause. The limitation, and, hopefully, elimination of nuclear weapons is a topic that affects the whole world. In my opinion we should therefore be reaching out for everyone to join in the effort.

For many years, DNA sequencing has been out of reach for our communities due to the cost of analyzing the samples, but our unique partnership with sequencing. com has removed the barrier of cost and will allow us to not only provide individual reports on the whole genome, but collate anonymous information across our community. Many people have died who have not been able to leave a legacy for our community, now is your chance to have your DNA stored for eternity.

The NAAV coffers were considerably depleted with the much increased cost of our convention this year. Unless inflation drops dramatically in 2025, some board members feel we may need to skip the convention for the coming year.

I DID NOT VOLUNTEER FOR THIS!

On the evening of March 19, 2021 I received word that my youngest son, Lance, had just passed away. I was, of course, shocked, but not completely surprised. He had suffered for a number of years from Addison's disease. He recently took early retirement from employment as a human resource manager, and had been looking forward to enjoying his lakeside home. He was sixty years old.

Addison's disease is attributed to improper functioning of the adrenal gland; so I was inevitably, once more, reminded of my daughter, Pat, who passed away in 1996; she too suffered, all through her teen years, from problems with her endocrine system. At the age of twenty, part of her pancreas had to be removed; in her forties, a malignant tumor was removed from her brain. Unfortunately, however, it had already metastasized to her lungs and she died at the age of 47. When she was dying, I told her I would never give up being an advocate for the abolition of nuclear weapons. BUT at the age of 98, I admit to having slowed down a bit.

After my son's death I was moved to examine some of the documents about radiation exposure in my possession. What follows are a few statements based on those examinations.

I spent the summer of 1946 at Bikini Atoll on a rescue tug, part of the "salvage unit" in Operation Crossroads, the first test firing of nuclear weapons after the end of World War II. I have suffered health consequences from that experience, and I assert that the unpleasant circumstances of Patricia's and Lance's deaths are attributable genetically to my experience. Various people representing the government have stated that is not possible; however, in my professional capacity I have interacted with several geneticists, all of whom say otherwise. In the 1990's I conducted research for my PhD in which I obtained questionnaire responses from a random sample of men who had participated in atmospheric atomic bomb tests. Twenty-one percent of my respondents replied that one or more of their descendants had health problems that they felt were attributable to their radiation exposure.

Recently. I have had occasion to review a report entitled IRRADIATION OF PERSONNEL DURING OPERATION CROSSROADS. Which was based on official U.S. Government documents, and presented by the esteemed authority on Radiation Health Physics, Dr. Karl Z. Morgan to the House Committee on veteran affairs in May, 1983. The report (formerly classified, but since de-classified) is 36 pages in length; the following are just two brief excerpts: On page 23:

"Almost all radiation measurements in the field related to external doses. There was no systematic measurement at Bikini for internal doses which personnel might get and continue getting for the rest of their lives by the inhalation, ingestion absorption of fission products or alpha emitters like plutonium at Operation Crossroads.

Thus, every aspect of Operation Crossroads, especially after July 25, 1946, was fraught with danger for the 42,000 people present. The documents show that because of the indifference to safety, the lack of caution in spite of grave ignorance, and other factors, it is probable that large numbers of personnel were exposed to very high levels of radiation, particularly internal doses from fission products and plutonium, which continue to irradiate long after the operation was declared closed and the target ships sunk."

Concluding paragraphs:

"The 'hairy-chested' 'attitude of indifference' to radiological matters contributed largely to the dangers to which the personnel were subjected. Such attitudes contributed to extensive violations of radiological guidelines (not wearing protective clothing like gloves, for instance) in direct contrast to the assumptions of the Defense Nuclear Agency.

The information in the documents does not allow us to make even rough estimates of the exposures. But it does allow us to dismiss as unwarranted any sweeping claims that the doses were "low" or "essentially insignificant" particularly as the Defense Nuclear Agency has made such claims without systematic reference to the veterans' detailed accounts of their own activities – data we consider essential to any serious judgement on the matter."

I conclude by observing that, in the period following the end of World War II, General Leslie Groves (Director of the Manhattan Project) was frequently quoted as being concerned about the possibility of claims being instituted by men who participated in Operation Crossroads. I can only wonder how much that attitude encouraged the "denial of harm" attitude which then prevailed among so many of the "top brass."
